President's Letter

Pat Kennelly, SBA President

It has been a busy and exciting year for the Stockbridge Bowl Association (SBA) and for me personally, in my first year as president, as we celebrate 75 years of stewardship of the Stockbridge Bowl.

We have met with the Massachusetts Department of Environmental Protection (MA DEP) as well as the Natural Heritage and Endangered Species Program as we continue to refine the protocols for our test of the narrow spectrum herbicide Fluridone as a control for invasive Eurasian Watermilfoil.

In late May, we utilized biologists and underwater cameras to identify emerging beds of milfoil in order to define the required test and control plots.

Additionally, we hired a MA DEP approved ecologist to modify the procedure to monitor the aquatic plants in the test sites. If plots can be successfully identified and the plants counted this summer, we would apply the herbicide in the early spring of 2023.

We would then do a recount of plants in the test areas in the summer to 2024 to measure the re-population of native species to the areas formerly covered in milfoil.

If the re-population meets MA DEP criteria, we would be allowed to do a full lake treatment with Fluridone.

At the same time, we are exploring substituting for Fluridone a newer herbicide, ProCellaCOR, which would allow us to do effective spot treatment of milfoil; this is our preferred outcome.

We have also partnered with the Town of Stockbridge to hire divers to hand harvest another invasive, the water chestnut, that has been discovered in the outlet of the Bowl. If left untreated, this species will form dense floating mats that disrupt aquatic ecosystems as well as cause problems for boaters and swimmers. We will continue to monitor this plant to make sure it does not become a problem for the rest of the Bowl.

Unfortunately, invasive plants are not only limited to the lake. The SBA will also turn its attention to the kiwi vines and barberry plants that threaten Bullard Woods while we continue to maintain the trails and bridges that allow hikers to access and enjoy the woods.

The SBA continues to be an active participant in the Stockbridge Bowl Stewardship Commission as the group strives to create a lake management plan, and we stand ready to assist the Town in its efforts to dredge the Bowl. The SBA has over \$1.5 million in funds that we raised for the dredging project. If necessary, we are prepared to try to raise additional monies after the Town has finalized the plan, the cost, and the amount of money the Town will commit to the project.

New President of the Stockbridge Bowl Association, Pat Kennelly

The SBA welcomes its new president, Pat Kennelly, who brings a wealth of knowledge to the job, from both her professional life and experience on the board.

A retired executive with over twenty-five years of management experience in marketing, operations, and finance, Pat served for fifteen years on the board of The Land Conservancy of New Jersey. She held positions including Treasurer and Vice-Chairman and chaired various committees that successfully worked to achieve the organization's national accreditation. She is now a Trustee Emeritus.

Pat joined the SBA board in 2013, when she first became the organization representative for the Beachwood community. She took on the task of chairing the Weeds Committee and gained enough scientific expertise to write about Stockbridge Bowl's weed problems and give a presentation at the Mount in 2014.

In 2016, she became Membership Chair, doubling the funds raised by SBA solicitations. Pat has worked on the Capital Campaign and is also a member of the SBA's executive committee.

Pat has enthusiastically embraced the challenge of her new position, and she has expressed her desire as follows: "I want to lead the organization to help it continue to fulfill its mission of stewardship of the Bowl, Bullard Woods, and Kwuniikwat Island, and wherever possible to collaborate with the Town of Stockbridge and local organizations in these efforts."


Information about individual items will accompany the exhibit, which will be available at the Stockbridge Library during regular library hours through September 6, 2022, the end of the Labor Day weekend.

Report from the Lake Committee

Gary Kleinerman, Town of Stockbridge Harbormaster, Chairman, Town of Stockbridge Zebra Mussel Committee

Harbormaster: At the end of last year, some new markers were put in the lake to designate no-cut areas. The areas are near Tanglewood beach, the western shore north of Kwuniquat Island, and from the Town Beach to Beachwood. These markers have red caps. Also new last year were three 6 MPH markers in the channel to deter power boats from speeding in that area.

The speed limit on the lake is 40 MPH outside the markers and 6 MPH inside the markers. Any swimmer outside the markers should be accompanied by a boat or have a swimmer's marker which looks like a football and is easily seen from a distance.

The speed limit on the lake from sunset until 10 a.m. is 6 MPH.

The docks at Bullard Woods and Kwunikwat Island are out and ready for use.

Invasive Species Inspection: The Zebra Mussel inspection station has been open since May 27 and will remain open through the Columbus Day weekend. If your boat or a guest's has been in any suspect waters, please take the boat to the ramp and have it washed. We have thus far been Zebra Mussel free and would like to keep it that way. If you park your car at the ramp make sure to leave a clean boat certificate on your dashboard.

Boat Ramp: Last year the head of the state Public Access Commission had a meeting with us, and we made some suggestions to improve the ramp. These improvements hopefully will be made, probably next year. Paving, run off control, fixing shore erosion and ramp extension are some of the topics addressed.

Crew Team

Stockbridge Bowl has played an important role in many lives, and none more so than in the lives of the Lenox High School Crew Team. Originally, the team was formed at Berkshire Country Day School in 2000. Lenox Memorial High School took over in 2002. Rowing is a physically demanding sport that requires excellent conditioning. The team competes in the fall season under the direction of Joan Schultz, who oversees the training and arranges the meets.

Participation is open to all students grades 7-12.

When one thinks of crew, a picture of young men comes to mind. That is not the case with the Lenox team. Young women are participants too. During one fall season there was only one fellow in the group. That not only worked out well for the team; it greatly increased the social life of the young man!!

The crew team would not be possible without the aid of Kripalu. The eight boats and equipment are all stored at the Kripalu shoreline. Swim tests and water safety are an important part of the training.

It is not just the crew members who enjoy the lake. Many of the parents take an active interest in their children's sport. A day of training can begin at 7:00 a.m. and end so that the crew members can be home by 5:00 p.m. Parents often come by with food and set up a grill. Do not be surprised when you see these rowers on the lake. They will be part of the SBA's 75th anniversary celebration.

Stockbridge Bowl Stewardship Commission

Michael Nathan, SBA Representative to the SBSC

The SBSC has covered a lot of ground this past year.

Topics discussed included:

- Dredging
- Aquatic plant control (*with herbicides or harvesting*)
- Cyanobacteria
- Habitat protection
- Invasives
- Nutrient load and source
- Thermal imaging
- Emergency response plan
- Septic issues impacting the Bowl

The state's Natural Heritage and Endangered Species Program (NHESP) asked the SBSC to develop a lake management plan (LMP). The LMP that is in the works reflects SBSC's priorities and time line. It will be written up by our consultant, GZA.

SBSC divided the list into top priorities, ongoing tasks, and reaction to Bowl emergencies, voting unanimously to make dredging the outlet and surrounding areas that are silting up a top priority for the health of the Bowl.

Other areas of interest for the LMP are a catalogue of species; the impact on quality of water from storms, sediment, nutrients, and salt from roads; bacteria (province of Tri-Town Health); best management practices; continued employment of Tom Coote; and inflow from run-off.

The SBSC is also concerned about harvesting this season, especially since the harvester is now allowed only in pre-assigned areas of the lake. We await the results of the SBA's milfoil survey, which will affect decisions regarding potential overlap of tasks, specifically the timing of herbicide use, dredging and harvesting.

Gary Kleinerman and Mike Buffoni reported to the SBSC on the zebra mussels checkpoint and the funding now in place for the 2022 summer season. The SBSC has also conducted water testing in Stockbridge Bowl under the supervision of Mike Buffoni.

Data was collected with a sonde (underwater probe) that was dropped from top to bottom in the deepest part of the lake to monitor seven parameters at one-meter increments. Additional testing has been done to assess pH, depth, dissolved oxygen, oxygen reduction potential, temperature, turbidity, specific conductance, and oxygen saturation percentage. Thirty-five water samples were also taken at the tributaries and at specific depths in the water column in the middle of the lake. These samples are analyzed for a multitude of parameters.

In light of the request by the Lake Drive Association for town sewer services to reach its 28 homes on Bowl, John Lidice reported on the topic of extending the Town sewer, especially to houses on the lake. No decision can be made, though, until maintenance and repairs to the Town sewer and water are done.

Special thanks are due to Jamie Minacci, who has served as chair, and to Roxanne McCaffrey for setting up the commission and putting the LMP in motion.

Her commitment to the Berkshires was evident through her hard work and dedication on the SBA board and her friendships with so many in the Berkshires community.



Laurel Hill Association

The Laurel Hill Association (LHA), with holdings of 460 acres of land in Stockbridge, recently completed major upgrades of its signature property, Laurel Hill Park, to restore its early design and enhance its functionality as a meeting place. Upcoming is revitalization of LHA's long-dormant Upper Bowker's Woods property, across Route 183 from the Norman Rockwell Museum. New trails, parking, and signage are planned.

Laurel Hill's major event for 2022 will be Laurel Hill Day on August 27. This year, LHA will join national celebrations of Frederick Law Olmsted's 200th birthday. The pioneer of American landscape architecture, Olmsted designed parks and scenic settings throughout the United States and in the Berkshires.

The weekend activities will include a panel discussion, "Olmsted in the Berkshires," Friday, August 26, at 5:30 p.m. in the Stockbridge Library. Saturday morning will bring a bundle of activities for children, including games and other entertainment. The main event will begin at Laurel Hill Park at 2:00 p.m., rain or shine.

"Olmsted's vision for landscape design can be seen throughout the Berkshires," said Deely. "Signature properties such as Wheatleigh in Stockbridge, Elm Court in Lenox, parks from the city of Dalton southward, all bear the Olmsted stamp." —*Lee Bolman*

New SBA Board Members 2022-2023



Phyllis (Patti) Klein, Chair, Governance Committee

Emeritus Board member, Peggy Reiser, served as Acting Nominating Committee Chair to prepare the slate for the 2021 Annual Meeting elections, with great appreciation from Patti Klein, Governance/Nominating Committee Chair. The Nominating Committee met seven times, mostly after Richard Seltzer, President of the SBA, announced in April 2021 his intention to resign as president effective at the 2021 Annual Meeting, feeling that in his ten years in office, he had accomplished what he could. The Board thanked him for his many years of dedicated service to the SBA.

The committee reviewed candidates for the balance of the president's term as well as other open positions on the board. Approximately 20 potential candidates were considered. There were six open positions for Individual Directors: five three-year seats in the Class of 2024 and one two-year term (Class of 2023). Four board members stood for re-election for three-year terms: Joan Cohen, Ira Golub, Patti Klein, and Joanna Wolff (see In Memoriam), leaving one opening, to which Pat Kennelly was elected. The single two-year term (Class of 2023) remained open.

At the August 2021 Annual Meeting, the nominee for the presidency proposed by the Board was Pat Kennelly, the Organization Representative for Beachwood, who was elected to the one year left from Richard Seltzer's term at the August 2021 Annual Meeting.

Although an Organization Representative is not precluded from becoming an officer by the SBA's By-Laws, Pat requested that she be nominated as an Individual Director. As a result, only one Individual Director position was then left unfilled.

The decision was made to leave that position open to allow the potential for a board member to be added during the year if an appropriate candidate was found. Because a number of the wonderfully qualified potential board members reviewed indicated that though not available in August 2021, they could be in the near future.

There were four Organization Directors whose terms were expiring in 2021. All the organizations chose to remain on the board, three with the representatives then in place: Canyon Ranch, Kripalu, and Lake Drive Association. Subsequent to the August 2021 elections, Beachwood named Stuart Yurman (see biography below) as its new representative when Pat Kennelly was elected as SBA President, and in the late spring of 2022, the Mahkeenac Boating Club notified us that Will Laidlaw was replaced as its SBA representative by James (Jim) Brooke. See biography below.

The terms of three officers were scheduled to expire in 2021: Vice-president (Patti Klein), Treasurer (Richard Gerszberg), and Secretary (Laurie Dubner). All officers filling terms that were expiring agreed to stand for reelection and were nominated by the Board. This was especially important for the position of Treasurer, as good governance practices dictate that the president and treasurer of an organization NOT be elected at the same time.

When President Richard Seltzer notified the SBA in April that he intended to step down from his position, the Nominating Committee looked to find a one-year president to maintain the separate term-ending dates for President and Treasurer; hence the new President, Pat Kennelly, was elected for only one year, to complete Richard Seltzer's term. Since Richard Gerszberg was continuing in his prior position as Treasurer, we did not have two new individuals serving as President and Treasurer.

The Slate was approved at the Annual Meeting of the Membership in August, at which the membership elected all nominees.

As noted every year, we are grateful to our volunteer board members for their service to the SBA, which depends on them for providing the "people power" for the many projects we pursue in our efforts to protect the Stockbridge Bowl and preserve it for the future. We are always in need of helping hands and new ideas.

We welcome our new President and our new board members:

Pat Kennelly (President): Although Pat has been the Beachwood representative for many years, we thought it appropriate to "reintroduce" her in her new role as President.

Our new board Organization Representatives:

Stuart Yurman (Beachwood): Stuart retired from his New York dental practice of 40 years and moved full time to his Beachwood home with his wife, Paula, in 2021. His retirement was short-lived, as he is now in private practice in Lee, as well as volunteering at Volunteers in Medicine (VIM) in Great Barrington. He has paddled, peddled, sailed, motored, and swum in the Stockbridge Bowl for 45 years. He knows where virtually all the rocks and weeds are located but is still looking for his favorite sunglasses that fell in three years ago. He is happy to share his love for the lake in his role as the Beachwood representative to the SBA board.

Jim Brooke (Mahkeenac Boating Club): From the main dock of the Mahkeenac Boating Club, Jim Brooke grew up swimming, sailing, canoeing, and kayaking on the Bowl. After college, Jim wandered the world, reporting from 80 countries, largely for The New York Times. Last fall, Jim moved home to Lenox, leaving Kyiv, Ukraine after six years, largely due to the worsening security situation. Jim's six-year-old son George likes swimming in the Bowl but says the weeds are "gross."
